Telemedicine

It is an area of telehealth, which remotely allows the interpretation of exams and the issuing of medical reports at a distance, supported by Information and Communication Technologies (ICTs).

CFM Resolution No. 1,643 / 2002, and later, defines that this specialty represents the practice of medicine through the use of interactive methodologies of audiovisual communication and data, with the objective of assistance, education and health research.

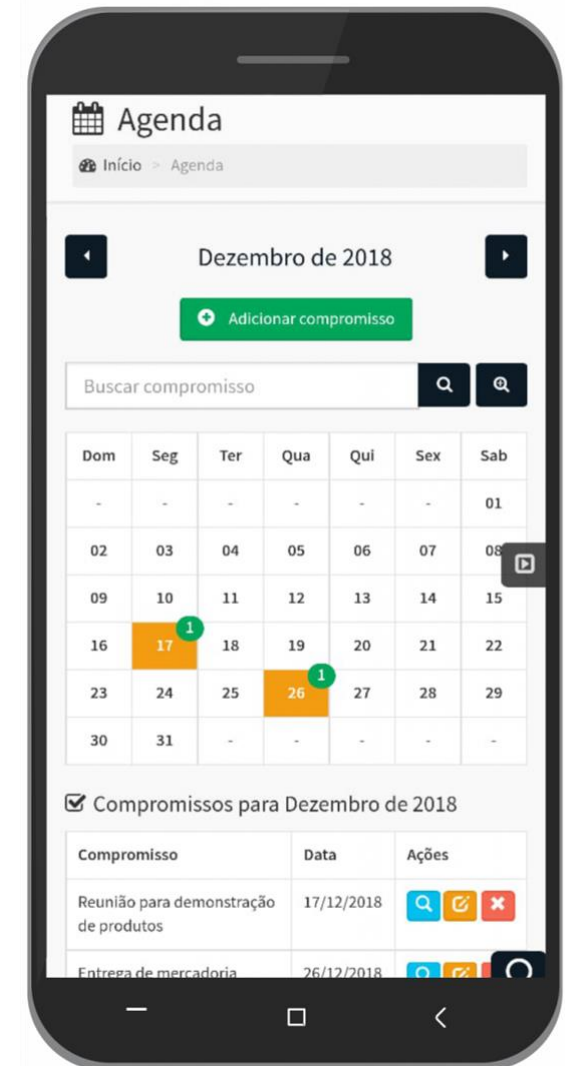
World Health Organization (WHO) recognizes the importance of this medical field, especially for cases in which distance and urban mobility is a critical factor in the provision of health-related services.

Whether in Brazil or in the world, telemedicine is an area that has broken down barriers, eliminating geographical distances and connecting specialists to other health professionals, managers and patients.

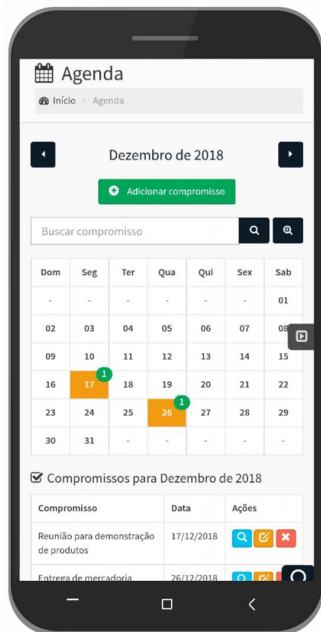
Functionalities



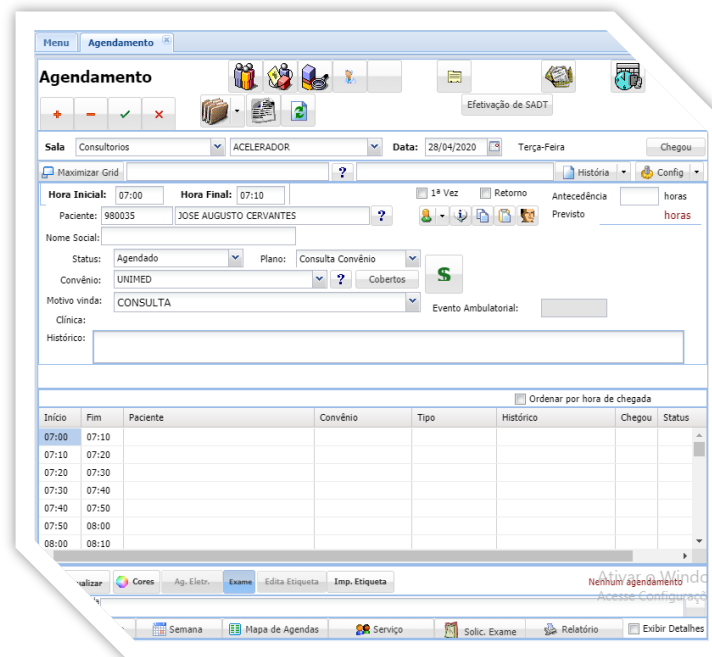
- . Scheduling, via mobile, by the patient, directly on the doctor's agenda;
- . Consultation, guidance and referral of the patient carried out remotely with the help of technology;
- . Remote monitoring of health and / or disease parameters;
- . Prior assessment, with application of protocols, for pandemics and other chronic diseases and follow-up care;
- . Conversation / communication between multiprofessionals to assess medical conduct and patient evolution;
- . Issuance of electronic prescription, with electronic signature through digital certificate;
- . Audio / video recording, with cloud storage, recording the beginning and end of care and later storage in the Electronic Patient Record, digitally signed by the doctor;
- . All systemic processes are within the norms established by ANS, ANVISA and CFM.
- . Payment method by credit and debit card, integrated with billing and cash flow.

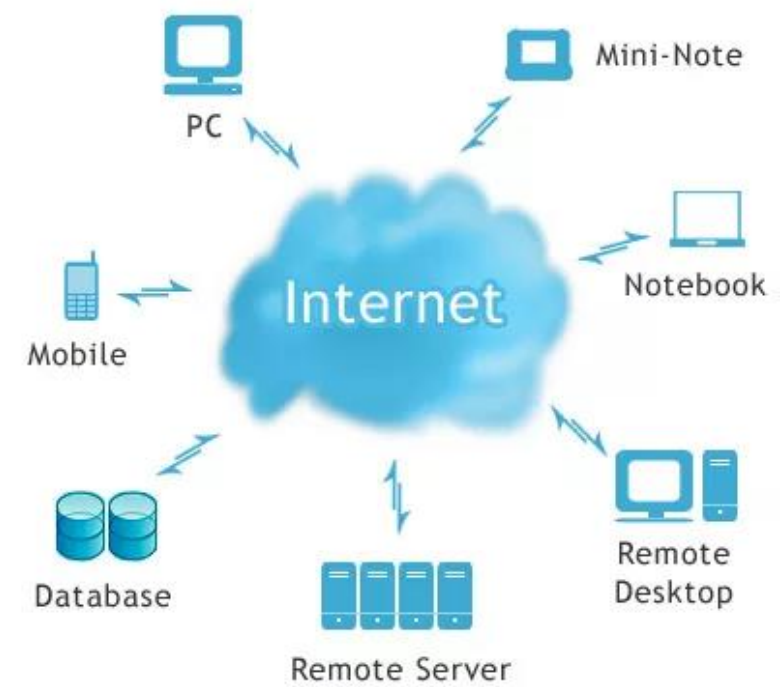

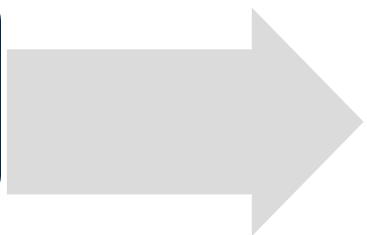


Drug Purchase at the Pharmacy

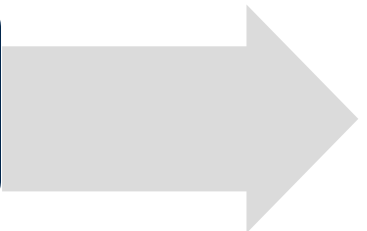
